



Dubai & Abu Dhabi Luxury Incentive Trip

Challenge Requirements

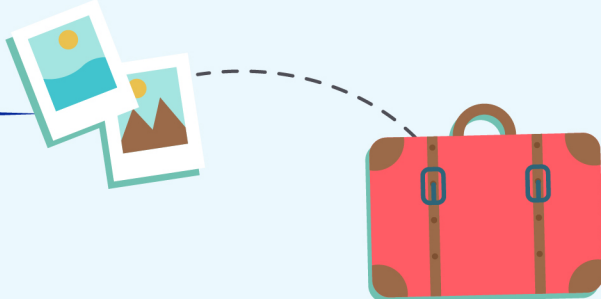
All Participants, including Diamond Masters, must maintain 300 PSV and 2,000 PGSV (inclusive of roll-up) from the start of the Challenge until the end of the Challenge Period.

Free & Subsidized Seats

Participants may exchange Points for up to 2 Seats, Subsidized or Free.

1 Subsidized Seat	1 Free Seat
50 Points	80 Points

The self-pay amount for subsidized seats is approximately USD 1,000. The exact amount will be announced in November 2025.



How to Earn Points

1. Monthly Master Qualification

Receive Points every month based on your qualified Master Rank.

Q. M. Rank	Master	Silver	Gold	Pearl	Jade	Diamond
Points	2	4	7	10	12	16

2. Master Rank Upgrade

If you upgrade your Master Rank compared to your qualified Master Rank in June 2025, you will receive an additional 2 Points starting from the second consecutive month you maintain the higher rank, and for each subsequent month you continue to do so.

You will receive 3 Points instead of 2 if you upgrade by 2 or more Master Ranks.

3. PGSV Overflow Points

Receive 1 Point for every additional 500 PGSV over 2,000 PGSV (not including roll-up), up to a maximum of 3 Points per month.

Challenge Requirement Salvage

If you maintained at least 200 PSV and 2,000 PGSV but did not meet the Challenge Requirement of 300 PSV for a month during the Challenge Period, you may “salvage” your eligibility by achieving 500 PSV and 2,500 PGSV in the following month. This will allow you to earn Points retroactively for the missed month.

This salvage option may only be used once during the Challenge Period and cannot be applied to the final month (January 2026).

Seat Transfer

- The Seat Transfer Form will be released at a later date and must be completed by 12 December 2025. Seats may only be transferred to your spouse, children, and your parents.
 - Any accompanying family members must be at least 5 years old.
 - Any minor children must be accompanied by a guardian that is an E. Excel Distributor.
- Seats that have been transferred may not be transferred again.
- All participants, including traveling family members, must submit their completed Registration Form and Indemnity Form by 12 December 2025. No changes will be accepted after this date. Failure to do so will result in disqualification.



Notes

- A detailed trip itinerary will be announced at a later date.
- Free Seats and Subsidized Seats are not inclusive of any airfare or air tickets. Participants must make their own travel arrangements to the Incentive Trip Start Location and from the Incentive Trip End Location. All expenses before the Incentive Trip Start Location, after the Incentive Trip End Location, and all non-itinerary expenses after the Start Location are at self-expense.
- Participants 28 weeks pregnant or more as of 1 March 2026 will not be allowed on the Trip. Pregnant participants may give up their Free Seat and receive USD 500 worth in free products, according to the below Terms and Conditions (3). Alternatively, pregnant participants may transfer their seat to their spouse, children, or parents, provided that they notify the Company by 12 December 2025.

If you violate the Company’s Policies and Procedures, if you are undergoing Investigative Proceedings, or if you are suspended, you may not participate in this Trip, and you will not receive any credits, Points, or rewards for this Trip.

Terms and Conditions
